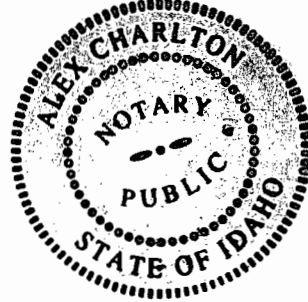


## Declaration of Candidacy



