


# Declaration of Candidacy

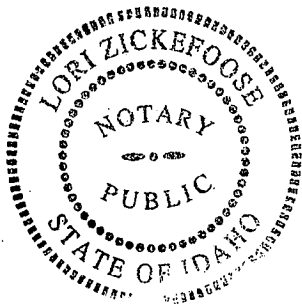

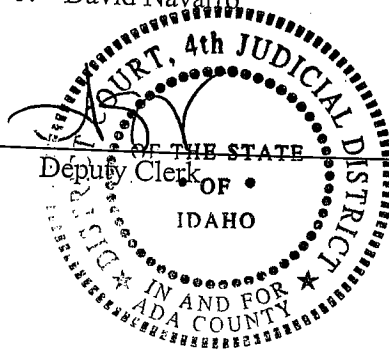
