



# Declaration of Candidacy

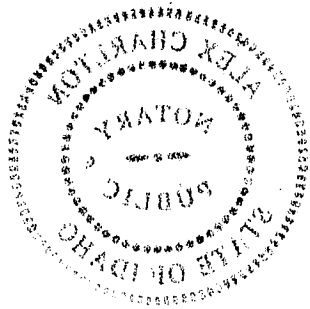
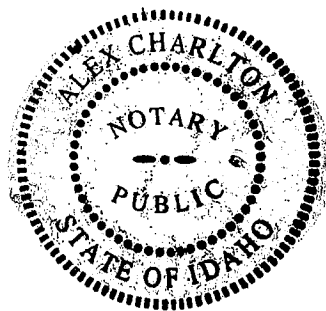

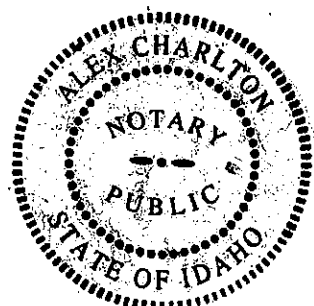
