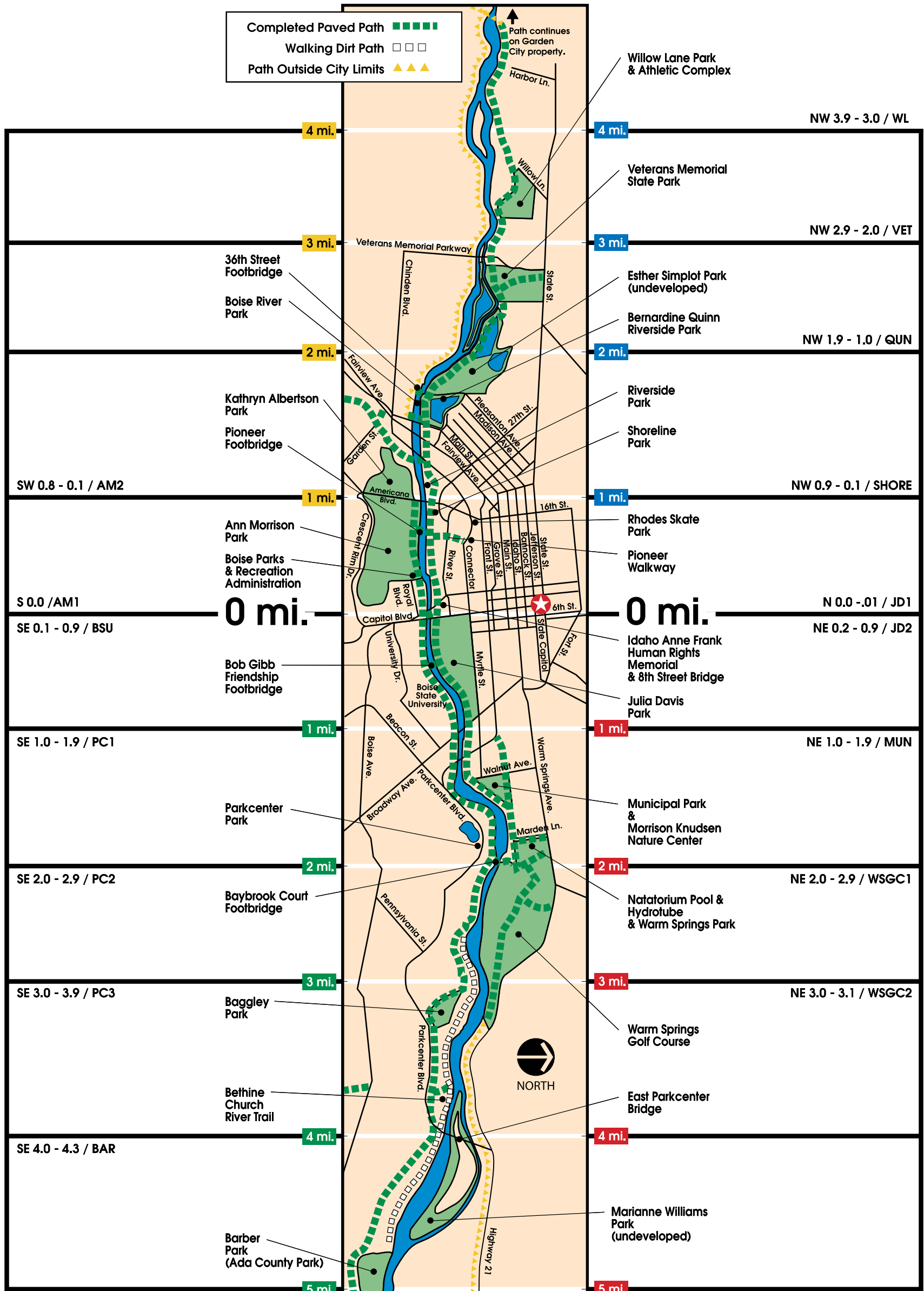


Boise River Greenbelt Distance & Orientation Trail System or DOTS

Bollards along the Greenbelt are about 1/2 mile apart and are numbered consecutively from the base '0' markers at the 8th street pedestrian bridge, on both sides of the river. These bollards are progressive in number and distance, heading away from zero markers both upstream and downstream; this creates four (4) distinct color coded grids (see Greenbelt Mile Marker, to the left).

The Distance & Orientation Trail System or DOTS

The Distance & Orientation Trail System (DOTS) on the Greenbelt within Boise City limits is designed to locate points of interest and aid in the event of an emergency. There are 112 spots painted over an 11 mile stretch of the Greenbelt within the Boise City limits from west of Lake Harbor to east of Warm Springs Golf Course. The description associated with the DOTS system outlined on this map directs you to the section of DOTS from the nearest street access (not all descriptions below are shown on the map).

NW 4.5 - 4.0 / LH (Not shown on Map)

State St. to Market Place Ln., to N. Lake Harbor Ln., Spur just past 2750 N. Lake Harbor Ln.

NW 3.9 - 3.0 / WL

State St. to Willow Ln., East Willow Lane Athletic Complex through main parking lot to drive way prior to overflow parking, middle of drive way/path.

N. Lander St. through parking lot to Greenbelt - spur west side of restrooms.

NW 2.9 - 2.0 / VET

State St. to N. Lander St. through parking lot to Greenbelt - spur west side of restroom. Wooden bridge is not rated for vehicles, Veterans Memorial Parkway northeast side of bridge, 27th St. to W. Pleasanton Ave.

NW 1.9 - 1.0 / QUN

27th St. to W. Pleasanton Ave.

Fairview to 30th St., Turn south past Shilo Motel, Fairview to 30th St. turn south past Shilo Motel. DOTS are in the tunnel under Main St.

27th St. to Fletcher St.

NW 0.9 - 0.1 / SHORE

Fire Training Station -1791 W. Shoreline, Northwest of Americana, Shoreline Dr. and S. 13th St. behind Shoreline Park Restrooms, River St. to Pioneer Ave.

NW 0 / Idaho Anne Frank Human Rights Memorial & 8th Street Bridge (Not shown on Map)

N 0.0 -.01 / JD1

Capitol Blvd. to Battery St., enter Julia Davis Park South of Art Museum. DOTS under 8th St.

NE 0.2 - 0.9 / JD2

Capitol Blvd. to Battery St., enter Julia Davis Park south of Art Museum - end of Capitol Blvd. underpass, across from Zoo road, behind Zoo, behind tennis courts, enter Julia Davis Park from far east end of parking lot at Broadway underpass.

NE 1.0 - 1.9 / MUN

E. Park Blvd. to S. Ferguson St., Park Blvd. to S. Walnut St., Enter from parking lot next to N.E. side of the Parkcenter Blvd. Bridge.

Behind Kimberly One Apartments, S. Walnut St. to enter Municipal Park, enter path on south side of shelter/restroom facility, behind MK Nature Center.

S. Walnut St. enter greenbelt spur from north side of Municipal Park.

Warm Springs Ave. to Marden Ln., past United Water.

NE 2.0 - 2.9 / WSGC1

Warm Springs Ave. to Marden Ln., towards Warm Springs Golf Course.

Warm Springs Ave. to E. Walling Dr. to E. Walling Cr.

Warm Springs Golf Course east of Pro Shop.

NE 3.0 - 3.1 / WSGC2

Warm Springs Ave. to Warm Springs Golf Course.



For example NW 0.5, indicates a location on the north side of the river and east of the 8th St. pedestrian bridge by .5 miles.



For example SW 0.3, indicates a location on the south side of the river and west of the 8th St. pedestrian bridge by .3 miles.

SW 0.8 - 0.1 / AM2

Americana Blvd., half way between Ann Morrison Park entrance and Boise River, close to Candy Cane Playground, 40 yards west of Ann Morrison Footbridge.

9th St. to W. Royal Blvd., entrance at end of cul-de-sac behind Parks & Recreation Administration Office -1104 Royal Blvd.

W. Royal Blvd. to N. Lusk, East end of 9th St. underpass between 9th & Capitol Blvd.

S 0.0 /AM1 W Royal Blvd. to N. Lusk EAST

East end of 9th St. underpass between 9th & Capitol Blvd.

SE 0.1 - 0.9 / BSU

Capitol Blvd. to Campus Dr., DOTS just east of Capitol Blvd. underpass.

In front of Morrison Center for Performing Arts. DOTS just east of BSU & Julia Davis footbridge.

Capitol Blvd. To Campus Dr. by Amphitheater.

Broadway to Campus Dr., between BSU Stadium and Pavillion,

Northwest end of BSU Stadium.

SE 1.0 - 1.9 / PC1

W. Beacon St. to north on S. Leadville Ave., enter at the intersection of Beacon St. and Parkcenter Blvd., Entrance on the northeast side of parking lot at 220 Parkcenter Blvd., behind Albertson's Corporate Offices.

E. Parkcenter Blvd. to Baybrook Cr.

SE 2.0 - 2.9 / PC2

E. Parkcenter Blvd. To Baybrook Ct., Parkcenter Blvd. To River Run Dr. to Riverstone Ln. to the Cottonwoods Apartments (foot traffic only or city utility vehicles only).

Parkcenter Blvd. to River Run Dr. to Riverstone Ln. to the Cottonwood Apartments. Follow easement to Greenbelt across wooden bridge.

Parkcenter Blvd. to River Run Dr. turn North on Springbrook Ln., Spur at 1935 Springbrook Ln.

SE 3.0 - 3.9 / PC3

Parkcenter Blvd. to River Run Dr. turn north on Springbrook Ln, Spur at 1935 Springbrook Ln. (Foot Traffic Only).

Parkcenter Blvd. to E. Spring Meadow Ln. (Private Ln). Access point is on the N.W. corner of intersection at E. Spring Meadow Ln. & S. Swallowtail Ln.

Parkcenter Blvd. between Law Ave. and E. Monterey Dr. Large power line crosses Parkcenter, north towards the Boise River, power line corridor leads to Greenbelt.

SE 4.0 - 4.3 / BAR

Parkcenter Blvd. to E. Gossamer Ln. (Private Ln.) 2266 E Gossamen Ln. spur leads to Greenbelt (foot traffic only or city utility vehicles only) at far east end of Parkcenter Blvd.

You will be required to complete a Community Park Application and to identify your route by using this map. Other requirements are outlined in our Policies for Event Planners. All requests **MUST BE** received 60 days prior to the event for processing.

Scheduled Activities and Areas that are Limited or Prohibited for Use

- A timed or race event that requires riding or operating a skateboard, roller skates, scooters, inline skates, bicycles or other wheeled recreation equipment is prohibited.
- 8th Street Bridge & Idaho Anne Frank Human Rights Memorial and walking dirt paths are prohibited.
