### **Housing and Community Development Division Notice of Public Comment Period and Meeting Draft Program Year 2020 Annual Action Plan**

The City of Boise invites the citizens of Boise to provide input on the Program Year 2020 Housing and Community Development Annual Action Plan. The Plan identifies Boise's affordable housing and community development needs including strategies to address those needs. The Action Plan also identifies priorities for funding with primarily Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME) funds expected to be received from the U.S. Department of Housing and Urban Development beginning October 1, 2020.

The Annual Action Plan describes how the City intends to use CDBG entitlement funding of \$1,427,480 and a HOME allocation of \$780,092 to address community needs and priorities identified in the City's 2016-2020 Five-Year Consolidated Housing and Community Development Plan. The 2020 Annual Action Plan also identifies proposed uses of CDBG and HOME program funds carried forward from prior years and program income.
