Positive Trends

Average first review timeframe targets were met for building permit project types New Multi-Family and New Commercial Buildings & Additions from June through August 2020.

New Multi-Family permits are being processed 18 days faster than this same time last year.

Considering the COVID-19 pandemic, Fiscal Year to Date permit numbers in each category are comparable and some exceeding numbers at this same time last year for Fiscal Year 2019.

Areas of Concern

Average first review timeframes for all other remaining permit project types are outside desired first review targets and taking days longer than this time last year. Some efficiencies in processing permits have been affected with adjustments in how work is conducted during the COVID-19 pandemic.

As of September 11, 2020, there are 55 Single Family Dwellings under building permit review. This is down from 87 Single Family Dwellings under review at this same time last year.

Project Updates

The following new commercial or new multi-family projects are under building permit review or in the resubmittal process: Whitewater Station Bldg. D, SARMC East Entrances, Bright Star Care Assisted Living, the Residences at 132 Main, Audra Storage Bldgs. 1-6, Meritage West Multi-Family, Overland Apartments, the Taper at Harris Ranch Multi-Family, 5th & Grove Podium, Lifepath Counseling Office, MGC Building, and 5th & Grove Apartments.

Project Updates (cont.)

Some larger commercial tenant improvement permit applications that are under building permit review or in the resubmittal process include: Phenix Salon, R&R BBQ, Revive Church Remodel, Highlands Apartments Exterior, Hayman House Restoration, Bodo Food Hall, WinCo Go Building TI, and Micron Bldg. 17C TI.

PDS has completed the review of some permits that have not been issued but are ready such as: Idaho Fish & Game Headquarters, State Street Apartments Bldgs. 8-11, R&L Carriers Terminal Building, R&L Carriers Fuel Canopy, Western Aircraft Foundation, State Street Apartments Bldgs. 1-7, Namaste Yoga Studio, Habitat Veterinary Hospital, Fox Fourplex, Boise Airport Employee Parking Garage, Fairfield Inn & Suites on Emerald, 6th & Grove Podium, MGC Office Building, 6th & Grove Apartments, Life's Kitchen, SARMC Outpatient Behavioral Health, Pioneer Crossing TI, and Islamic Center of Boise Addition.

Other Trends

The average time a permit waits for a customer to pick it up (customer pick-up time) after PDS has completed the review showed some changes when compared to last month. Single Family Level 1 permit customer pick-up time increased from 20 days to 32 days currently. Single Family Level 2 permit customer pick-up time increased from 10 days to 20 days currently. Tenant Improvement Level 2 permit customer pick-up time increased from 15 days to 28 days currently. All other categories either remained the same or varied slightly from last month.
