The City of Boise encourages and supports the organization of registered Neighborhood Associations. Neighborhood Associations are required to submit an annual report by Sunday, January 31st, 2021 to retain 'active' status with the City of Boise.

Annual reports are used to document and celebrate 2020 neighborhood association efforts as well as help city staff and neighborhood associations plan for the upcoming year.

Once you begin the annual report, your answers will be automatically saved, but you will only be able to return to your answers if completing the report on the same computer.

The online submission process can be completed in three steps:

- 1. **Preview the annual report questions.** Once you begin the online submission process, you will only be able to return to your answers if using the same computer you started the process from.
- 2. **Preview and submit the <u>Board Contact Form</u>**. Please note: THIS IS REQUIRED as part of your submission.
- 3. Complete and submit the Annual Report online by January 31, 2021. Once you begin the online submission process, you will only be able to return to your answers if using the same computer you started the process from.


