RECYCLING/REUSE COORDINATOR

The designated Recycling/Reuse Coordinator is responsible for communicating recycle, reuse or salvage for reuse goals and activities to the owner, company project manager, company workers, any subcontractors and to any other party affiliated with the deconstruction or demolition work.

MATERIAL AND WASTE MANAGEMENT RECYCLING AND/OR REUSE

All appliances, solid metals accepted at local metal recyclers and woody yard debris 10 cubic yards or greater are required to be recycled. In addition, other desired material items can be further salvaged by the contractor and must be offered to local Reuse Stores/companies prior to disposal. The building official may require independent third-party audit where deemed necessary.

NOTICE VERIFICATION

Provide verification of an email notice, with exterior and interior photos (front, back, kitchen, doors, fixtures, etc.), of available materials that was provided to the list of Reuse Stores and the City prior to the project scheduled start date. Allow seven (7) business days for any response or communication of interest in materials. Indicate acceptance of, rejection of or no response to offered material items.

If materials are requested for recycle and/or reuse, adequate time shall be provided for the contractor, or designated person, to carefully remove the requested material items, haul and/or set aside the materials for the Reuse Store/company to collect prior to project work completion.

If there is no communicated interest in materials for recycle and/or reuse from Reuse Stores/companies for the building or site, the work may proceed, including recycling required materials at an area Recycling Company.

ESTIMATE OF DIVERSION OF MATERIALS, WASTE, DISPOSAL METHODS, DESTINATIONS, AND HAULING

The following is a proposed estimate of identified materials and waste expected on this project, including diversion from landfill waste methods, destinations and hauling. Hauling must comply with the City of Boise Solid Waste Ordinance. The project Recycling/Reuse Coordinator is responsible for confirming acceptance of materials with the recycling/reuse destination and hauling method.
