

Dear Craig,

Enclosed find our annual report for 2010.

In June of 2010, it was discovered that our former campaign manager had unilaterally altered the terms of his contract in a manner that caused great concern.

In January 2010, Ryan Hill agreed to accept \$2,500 per month as an independent contractor for the campaign. On prior occasions, at various times and in agreed amounts, Mr. Hill had previously paid himself for management services by writing a check to himself and properly reporting the cost as an expenditure. No one on the campaign expected that to change.

Mr. Hill decided, without advising anyone related to the campaign, that beginning in January of 2010 he would instead pay personal expenses with the campaign account and otherwise co-mingle personal funds in the campaign committee account.

When this was discovered the campaign: 1) terminated Mr. Hill; 2) retained the services of a CPA to examine the books and records of the committee for other anomalies and to account for all personal versus committee expenditures, 3) reported the matter to the Attorney General.

Attached you will find a copy of the letter from the Attorney General finding that because Mr. Hill did not withdraw more monies from the account than he was due under his contract, no criminal or civil violations occurred and no further action would be taken by their offices.

I have considered carefully and sought legal advice on how to report these matters on the campaign finance report. I have considered whether it appears more anomalous to report an expenditure to a grocery store or restaurant, categorized with an obviously inconsistent "M" for management services, or to report the expenditure as one to Mr. Hill, with a notation next to his name of "Draw on Management Services" and a code of M for management services. The second option more accurately describes the events and expenditures and therefore have filed the report in that manner.

I would not write if the law and the matter were not without some ambiguity. Please advise if you require any changes to the report or if you need any further information
