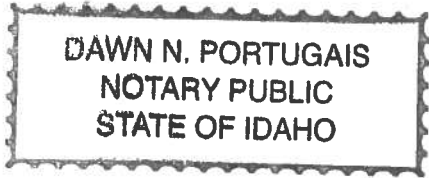


Declaration of Candidacy

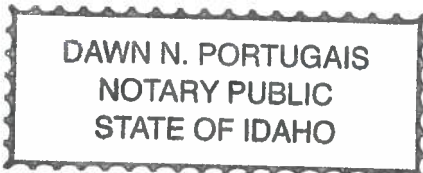
