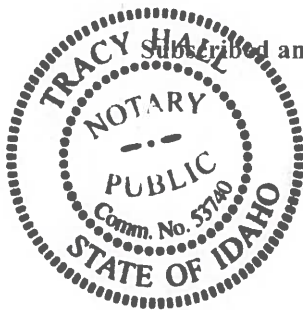


# Declaration of Candidacy
