PLEASE NOTE: *The dates shown are statutory deadlines for election actions. When possible, city officials are strongly encouraged to complete each step in the election process as early as practicable.*

Thursday, August 19, 2021	For cities choosing to change Mayor & Council salaries: deadline for publishing an ordinance passed by the Council to change elected official salaries effective January 1, 2022.	50-203
Friday, August 20, 2021	First day for city clerk to publish the notice of candidate filing deadline, which must include: the name of the city, the date of the election, the offices up for election, that declarations of candidacy are available from the city clerk, and the filing deadline. The notice must be published <u>once</u> as a legal notice in the official city newspaper between August 20 and August 27, 2021.	50-411
Monday, August 23, 2021	Candidate filing period opens at 8:00 a.m.	50-410
Friday, August 27, 2021	Last day for city clerk to publish the notice of candidate filing deadline, which must include: the name of the city, the date of the election, the offices up for election, that declarations of candidacy are available from the city clerk, and the filing deadline. The notice must be published <u>once</u> as a legal notice in the official city newspaper between August 20 and August 27, 2021.	50-411
Friday, September 3, 2021	Candidate filing period closes at 5:00 p.m. City clerks need to keep their office open until 5:00 p.m.	50-410
Friday, September 10, 2021	Last day for city clerk to notify county clerk of candidate names for the November 2, 2021 election.	34-1404
Friday, September 10, 2021	Deadline for write-in candidates to file their declaration of intent with the city clerk indicating the office and term for which they are running and affirming their qualifications to hold the office, if elected.	50-410 34-702A
Monday, September 13, 2021	Last day for city clerk to certify the wording to the county clerk for a bond, levy, initiative, referendum, recall or any other ballot question ordered for the November 2, 2021 election.	34-106
Friday, Sept. 17, 2021	Deadline for candidates to withdraw their candidacy by filing a notarized statement of withdrawal with the city clerk.	34-1405A
Friday, October 8, 2021	Last day to pre-register to vote for Nov. 2, 2021 election; voters may still register when voting in-person absentee, early voting, or at polling place on Election Day.	34-408
Friday, October 22, 2021	Mail-in absentee ballot requests must be received by 5:00 p.m. by the county clerk.	34-1002
Fri., Oct. 29, 2021	Last day for in-person absentee voting or early voting, which ends at 5:00 p.m.	34-1002 & 34-1012
Tues., Nov. 2, 2021	Election Day. Absentee ballots must be received by 8:00 p.m. to be counted.	34-1005 & 34-106
Friday, November 12, 2021	Deadline for the board of commissioners to certify the election results to the city. The election results by precinct must be included in the council meeting minutes in Nov. or Dec.	34-1410 & 50-412
