Registration Information

Boise Parks and Recreation's Playcamps will provide a variety of experiences over the course of the summer. All camps will be closed June 20th in observance of Juneteenth. And July 4th and 5th for Independence Day.

- **Ivywild Park:** 416 W. Ivywild St **(11 weeks)**
- **Jullion Park:** 3901 N. Jullion Way **(9 weeks)**
- **Sunset Park:** 2625 N. 32nd St **(11 weeks)**
- **Winstead Park:** 6150 W. Northview St **(10 weeks)**

11 weeks are available at Elm Grove, Ivywild, Sunset, and Cassia park locations only. Weekly activities include art lessons, games, sports and many other programs. Parents will receive a weekly Newsletter every Friday afternoon. Copies will be available every Monday morning at Camp as well.

Enrollment Fees

All-Day Weekly Fee: 7:30 a.m. to 5:30 p.m. Resident: \$96, Non-Resident: \$148.25

Full payment is required at the time of registration. Payments can be made at Fort Boise Community Center, on the web at <https://www.cityofboise.org/departments/parks-and-recreation/activity-registration/> or by calling 208-608-7680. Payments are not accepted at park locations. Fees are not pro-rated for unattended days. Early registration is recommended as Playcamp registrations are taken on a first-come, first-serve basis and camps are often full.

Refunds or Credits

A request for refunds, transfers or credits must be received ten (10) days prior to the week of the program that the child will not be attending. A \$15 processing fee will be assessed on all cancellations. Processing fees are not charged on transfers. No refunds or credits will be given for missed, sick or suspended days. Financial Assistance

Scholarships are available to those who qualify based on income requirements. Scholarship applications must be submitted two weeks prior to the program date; call Fort Boise Community Center at 208-608-7680.

Signing In and Out

Parents, guardians and authorized individuals listed on the Participant Form are required to escort and sign the child in and out of the program daily unless the participant is authorized to walk/bike to Playcamp. A picture ID is required of all individuals picking up a child.

Request for an emergency participant pickup by someone other than the individuals listed on the Participant Form must be submitted in writing, either in person or scanned/emailed to benglish@cityofboise.org or ccamacho@cityofboise.org. The letter must include the child's name, Playcamp site, date, and the name of who will be picking the child up along with the guardian's signature and copy of photo ID. Phone request and changes will not be accepted.

If custodial issues are in dispute, Boise Parks and Recreation requires that you provide us with a copy of your divorce decree and custody arrangement.

Meals and Snacks

Participants must bring a sack lunch and two snacks each day (please note that refrigeration is not available). Please remember that your child will be playing hard and pack their lunch accordingly. Please include a water bottle so your child can drink plenty of water during warm weather.

Illness and Emergency Policy

If your child has been ill or had any COVID-19 symptoms, she/he may not be allowed to attend camp for a few days for the protection of staff and other campers. If your child becomes ill at Playcamp, you will be notified and will be expected to pick up the child within one hour. Please develop a backup plan in case this occurs. If staff can't reach you, the emergency contact person will be called.

Guardians will also be notified if a participant has evidence of head lice. Due to the contagious nature of lice, all participants with evidence of lice (nits or bugs) must be treated and considered lice-free before returning.

Appropriate Clothing

Durable shoes for active play are needed (tennis shoes for physical activities are highly recommended). Appropriate clothing is important with cool mornings and warm afternoons. We may call you to either, pick up your child or bring them additional clothing if they are not dressed appropriately. Please label all belongings including clothing, water bottles, sunscreen and towels.

Conduct & Discipline

Playcamp promotes learning and respect in a safe environment; we have a strict no-bullying policy. All participants, parents/guardians and employees are responsible for reading and familiarizing themselves with the following policy and procedures. Examples of inappropriate behavior include (but are not limited to):

- Inappropriate action/behavior: Abusive language and/or inappropriate gestures/actions directed to-ward participants, staff, or other persons.
- Harm to others: Physically assaulting another person (participants, staff or other persons), including striking, pushing, shoving, spitting, proximity intimidation and/or grabbing; or other attempt or threat to physically injure another person.
- Harm to self: Physically harming/injuring self or attempting or threatening to do so.
- Misuse/Damage of property: Improper care or misuse of items that belong to the City, site location or items belonging to another person.
- Stealing: Removing property belonging to others, the City, or other facilities without permission.
- Non-compliance with rules: Non-compliance with program and facility rules.
- Inappropriate touching of others

If a participant's behaviors are disruptive, staff will give a verbal warning identifying inappropriate behavior and possible consequences should the behavior continue. If the child continues to be disruptive, the following progressive discipline steps will be used to get a child back on track with the code of conduct policy:

1. **1st Infraction:** If inappropriate behavior continues, a staff member will have the participant go to a "quiet-time" for five to ten minutes prior to rejoining the group. The staff member will reiterate the de-sired behavior and consequences should the behavior continue.
2. **2nd Infraction:** If inappropriate behavior continues to occur or becomes more serious, a staff member will call the participant's guardians and notify them of the continued inappropriate behavior. A Student Behavior Report will also be sent home.
3. **3rd Infraction:** Staff will inform the Playcamp Supervisor of the inappropriate behavior and the Supervisor will call the participant's guardian to discuss a course of action; consequences may result in time away from Playcamp.
4. **Suspension:** The steps listed above are used to correct behavior in most cases. If these steps are un-successful, a participant may be suspended or expelled from the program.

Please note that these steps are used as a guideline. Exact responses to behaviors are situational and depend on the severity of the inappropriate behavior.

Mandatory Reporters

Idaho State Law requires staff to make reports of suspected child abuse or neglect. Staff will report any suspected abuse to Child Protective Services.

Valuables & Toys

Valuables, toys and electronics are not permitted at Playcamp. Cell phones must be kept in the participant's bag during program hours. The City of Boise is not responsible for lost or stolen items.

Weather

In the event of inclement weather, Playcamp will still be offered. All participants should report to their Playcamp site by 9:30 a.m. We will then transport participants to their designated alternative site and notify parents via phone of the change in location. At the end of the day, participants should be picked up at the alternative site.

- **Rain:** Participants will attend alternative sites on rainy days. Please ensure that participants have coats and appropriate clothing as they will not be moved for brief rainstorms that clear up quickly.
- **Heat:** Participants will attend alternative sites on days when the temperature is above 100° unless the temperature does not reach 100° until the end of the day. For hot days that do not reach 100°, Playcamp staff will limit physical activities and ensure adequate water intake.
- **Air Quality:** Smoke from surrounding wildfires can affect the air quality in Boise during the summer. Based on readings from the Air Now website, located at www.airnow.gov, participants will be moved to their alternative site when the air quality is considered unhealthy (colored in red). On most occasions air quality is worse in the morning and improves as the day goes on.
