



## **CITY OF BOISE PROPERTY TAX REBATE PROGRAM APPLICATION INSTRUCTIONS**

The City of Boise launched a Property Tax Rebate Program for Boise homeowners who applied to, and were approved for, the State of Idaho's Circuit Breaker Program in April of 2022.

Qualified residents may receive a tax rebate for their remaining City of Boise property taxes, after accounting for state Circuit Breaker reductions.

### **PROPERTY TAX REBATE PROGRAM QUALIFICATIONS**

- Must be participating in the State of Idaho's Circuit Breaker Program in 2022
- Must still own the home/mobile home on June 30, 2023
- Must have paid your 2022 property taxes in full by June 30, 2023

### **TO APPLY FOR THE CITY OF BOISE PROPERTY TAX REBATE PROGRAM:**

Fill out the included application. Information required includes:

- Parcel number (can be found on your tax bill, or on the Ada County Assessor website: [adacountyassessor.org/propsys/index.jsp](http://adacountyassessor.org/propsys/index.jsp) by entering your home address)
- Primary property owner name and address
- Social Security Number (SSN) or Tax Identification Number (TIN) or Employer Identification Number (EIN)

**Your completed application must be returned either by mail or in person to the City of Boise by May 1, 2023 at the following address:**

Property Tax Rebate checks will be sent in August 2023 to the primary property owner. The program is a one-time payment that may not be available in future years.
