1. This application is for an evaluation of the existing structure only. It **does not authorize** the relocation of the structure or any other work. A separate building permit is required to move the structure to a site within Boise City limits.
2. Posting a bond is required for each site if proposed location is within Boise City limits. A bond will be required at the original site for site stabilization and clean up, the amount will be set by your inspector during the Proprietary Inspection.
3. House mover is responsible for disconnecting all utility lines and facilities.
4. Additional site permits will be required prior to moving the structure. See list below.

To move the structure, the following additional requirements apply:

- A separate building permit and associated trade permits (electrical, mechanical and plumbing) are required to place the structure on the new site.
- House mover is responsible for obtaining a [State of Idaho Moving/Over Road Permit](#).
- Erosion and Sediment Control permit.
- [Sewer Cap Permit](#) on the original site.
