### **Application Acceptance**

Please follow the guidelines below for all Fire sprinkler Quick permits. Be sure all items are addressed, or we will not be able to consider the request. Not all requests will be approved; approval will be subject to careful consideration of all relevant factors.

### **Eligible Projects**

Quick permits are limited to modifications to existing systems where no hydraulics is necessary:

- 1. Relocation of existing sprinkler heads.
- 2. Change upright "shell sprinkler heads to pendent type heads on a <u>head-for-head</u> basis in new Tenant Improvements.
- 3. Projects that don't require new or revised hydraulic calculations.

## **Application Submittal**

Fire Sprinkler Quick Permit applications and plans can be submitted to the City by two methods. *This checklist must be completed no matter which method is used.* 

#### 1. Electronic Submittal
