## **VEHICLE RESTRICTIONS:**

- 1. Construction Overnight Parking permits will be issued in conjunction with a Construction Use License or with a Parks Construction Contract.
- 2. All vehicles, (i.e. cars, trucks, trailers) parked on overnight in a park, regardless of use, must always have a vehicle permit displayed.
- 3. Vehicles parked overnight must be an active part of the construction project.
- 4. Boise Parks and Recreation reserves the right to limit the size and number of vehicles in a park associated with a project.
- 5. The permit will identify the vehicle, license number, size and weight of vehicle, purpose for parking overnight, park facility, date and time.
- 6. All vehicles identified as part of the project must have a drip pan placed to protect the pavement from oil and grease.
- 7. A Vehicle Permit does not allow any person to set up camp, tents, or any temporary shelter, or to use house trailers, campers, motorhomes or automobiles for the purpose of overnight camping in any city park between sunset and sunrise.
- 8. Any vehicle or trailer parked on park property without a Construction Overnight Parking permit will be towed.
- 9. Vehicle Access/Overnight Permits require no less than 48 hours to process.
- 10. All information must be completed for approval.
