Notice of Available Grant Funds and Application Workshop for the City of Boise's 2019 Program Year Annual Action Plan

The City of Boise's Housing and Community Development (HCD) Division invites eligible partner agencies to apply for approximately \$325,000 in local and federal funding. A Grant Application Workshop will be hosted in the Belgravia Conference Room at 150 N. Capitol Boulevard (2nd Floor), Boise, Idaho on April 26, 2019 at 10:00 a.m. Staff will be available to explain the programs, projected funding levels and review the grant application process.

A portion of the Community Development Block Grant (CDBG), the City's Neighbors In Need Trust Fund, and Homeless Prevention and Rapid Re-Housing Programs are available in the form of grants for community organizations. To apply, organizations must be a 501(c)(3) and serve low income Boise households. Applications are available on-line at <http://hcd.cityofboise.org> beginning April 15, 2019. Funding priorities will be made to organizations that: provide housing for households experiencing homelessness, homelessness prevention, serve persons that are chronically homeless according to HUD's definition, serve persons with disabilities, or serve persons who have traditionally been among those least likely to apply for housing and other services. Agencies will need to include leverage and capacity for the management of federal funds. The grant submission deadline for applications is May 16, 2019. Applicants are encouraged to attend the Grant Workshop on April 26, 2019 at 10:00 a.m.

Applications will be reviewed and ranked by the Citizen's Advisory Committee on May 30, 2019 at 8:30 a.m. and included in the Draft 2019 Annual Action Plan. This plan will have a separate public hearing.

Participants may request reasonable accommodation from the City to facilitate participation in the Grant Application Workshop. The workshop is accessible to persons with physical disabilities. Participants may request a language interpreter to assist in their participation in the hearing.

Individuals wishing to receive information about CDBG, or the City's Neighbors In Need Trust Fund and Homeless Prevention and Rapid Re-Housing Programs prior to the meeting; or persons that will require language interpretation or special assistance to accommodate physical, sight, or hearing impairments, please contact HCD at (208) 570-6832 at least five (5) business days in advance of the hearing.
