## NOTICE OF FINDING OF NO SIGNIFICANT IMPACT AND NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the City of Boise's Housing and Community Development (HCD) Division.

## **REQUEST FOR RELEASE OF FUNDS**

On or about **April 1, 2020, the City's HCD Division** will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of funding under Title II of the Cranston-Gonzales National Affordable Housing Act, known as the HOME Investment Partnerships Act (HOME). The project known as 6<sup>th</sup> and Grove, will receive the funds for the purpose of site-preparation and new construction of a 50-units multi-family apartment complex located at 116 S. 6<sup>th</sup> Street, Boise, Idaho on approximately .27 acres of previously undeveloped land, which will provide housing for 0-80% of Area Median Income, along with some above 80% of Area Median Income units.

## FINDING OF NO SIGNIFICANT IMPACT

The City's HCD Division has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. ## **OBJECTIONS TO RELEASE OF FUNDS**

HUD will accept objections to its release of funds and the City of Boise's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the Responsible Entity (RE) (b) the RE has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58) and shall be addressed to HUD at **Mr. Todd Adkins, 1220 SW 3rd Ave., Suite 400, Portland, OR 97204-2825.** Potential objectors should contact HUD to verify the actual last day of the objection period.
